The Pacific Ridge Exploration Ltd. submitted their 2007 Annual Report to the Nunavut Water Board (NWB) on November 5, 2008. The preparation and submission is a requirement of Part B, Item # 2 of Water License #2BE-KAZ0609. ### Comments / Recommendations

As a result of my review I have determined that,

- The Annual Report was submitted by Pacific Ridge Exploration to NWB on November 5, 2008. Part B, item # 2 of the Water Licence 2BE-KAZ0609 requires that the annual report must be submitted to the NWB no later than March 31<sup>st</sup> of the year following the calendar year being reported. This incident is considered an administrative violation and has been forwarded to INAC's Field Operations Division.
- Pacific Ridge must submit their 2008 annual report to NWB no later than March 31, 2008.



- Future reports should reference whether Uranium Mineralization has been encountered during drill.
- The Annual Report did contain all items that are required to be in the report pursuant to Part B, Item #2 of Water License 2BE-KAZ0609.
