Re: 2BE-KDP1722 Water Licence Inspection Form – Response to Section 3 Action Required

Hello Atuat

Thank you for forwarding a copy of the Inspection Form detailing Nunavut Water Board's August 17, 2018, 2BE-KDP1722 Water Licence Inspection conducted on Dunnedin Ventures Inc's Kahuna Property.

Section 2 of the Inspection Form is contradictory and cites Non-Compliance with the Licence but states in the Comments that "No instances of non-compliance were noted at the time of the inspection."

Dunnedin Ventures respectfully requests that the Non-compliance citation in Section 2 is removed and the Inspection Form corrected so that the Kahuna NWB Licence Inspection record accurately reflects the findings of the inspection.

Section 3 of the Inspection Form cites Action Required and requests that the proponent will submit to the Inspector before March 31, 2019 a brief summary of how hazardous waste is stored and where in Rankin Inlet prior to shipment to a treatment facility.

To satisfy the Action Required request cited in Section 3 of the Inspection Form, Dunnedin respectfully provides the following summary of our hazardous waste storage and shipping protocols:


There are ten sealed 205 litre steel drums containing hazardous wastes that are temporarily stored at Dunnedin's Kahuna Camp. There are 7 sealed 205 litre drums containing incinerator ash generated by burning Pacto toilet wastes, food wastes and miscellaneous combustible camp wastes temporarily staged adjacent to the camp incinerator. There are 3 sealed 205 litre metal drums containing used oils recovered from motorized equipment utilized by Dunnedin to support exploration activities that are temporarily staged within a small berm adjacent to the camp generator shed.

These drums are to be back hauled from the Kahuna camp via Dunnedin's permitted overland winter trail to Rankin Inlet in April or May 2019. The drums will then be temporarily staged in a locked Seacan shipping container rented to Dunnedin from Curley Construction Ltd. and located on the east side of the intersection of Qupanuaq Street and Tigtak Street on Division I-29 of Lot 1001, Quad 55K/16 68912 C.L.S.R./1614 L.T.O. in Rankin Inlet. The 3 drums containing used oils will be staged in a portable secondary containment berm within the Seacan.

In July 2019 the drums will be strapped and secured onto drum pallets (3 - 4 drums per pallet) and delivered to NSSI or NEAS loading dock crews in Rankin Inlet. Dock crews will load the drums on a south bound sealift to be received by and forwarded to authorized environmental disposal company Solva-Rec Environnement Inc. experts in environmental protection. <http://www.solva-rec.com/home>
