I wanted to take this opportunity to introduce myself and follow up with AREVA's amendment request of the NWB licence 2BE-KIG1318. As you know, Naomi Stumborg has left AREVA for a new opportunity and I will be taking over as the licencing contact for AREVA Exploration.

I am aware that the comment period has closed for the attached amendment request. NPC has reviewed the amendment application and determined that the application does not change the scope of the originally reviewed project (via email April 23, 2015), and the NIRB also determined the proposed amendment does not change the general scope of the original project activities and therefore is exempt from the requirement for screening (via email May 6, 2015).

As I am new to this process, can you provide me with the anticipated timeframe for a decision on the amendment application? AREVA plans to mobilize to Kiggavik camp on June 8, 2015 and will need to know the decision on this amendment shortly after as we plan to move to the St. Tropez area mid to late June 2015.
