Dear Mr. Aglukark and Ms. Granchinho:

Re: Kiggavik Exploration Licence 2BE-KIG0812 – Amendment Request to Authorize Drilling During a Low Flow Artesian Conditions and Allow Drilling within 30 metres of Ordinary High Water Mark in Andrew Lake area and Mushroom Lake.

Please accept the enclosed amendment request application for the Nunavut Water Board (NWB) Licence 2BE-KIG0812 to allow drilling to continue when low flow artesian flows are encountered and allow drilling within 30 metres of the ordinary high water mark on Andrew and Mushroom Lakes. The amendment application is enclosed for the review of the Nunavut Planning Commission (NPC) and the Nunavut Impact Review Board (NIRB) to determine whether an additional conformity review and/or screening decision will be required respectively. Such drilling would allow further exploration for uranium deposits as well as provide valuable information regarding the groundwater in this area.

Exploration at the Kiggavik Project received a positive conformity determination against the Keewatin Regional Land Use Plan (KRLUP) by the NPC on December 15, 2006. The KRLUP has not been updated since that conformity determination and AREVA remains committed to following all conformity terms outlined in Chapter 6 as determined in the original conformity determination. We also re-commit to following the Code of Good Conduct for Land Users and the DIAND Caribou Protection Measures as per Appendices G and H of the KRLUP respectively.



The Project received a positive screening decision by the NIRB in April 2007 under the file No. 06AN085. NIRB subsequently determined a change in the Project scope and issued additional recommendations in a letter dated August 30, 2007. AREVA remains committed to this, all other recommendations found in the NIRB screening decision report issued April 3, 2007 and the additional terms and conditions outlined in the August 30, 2007 letter. In addition, we are confident that the environment protection measures outlined in the NWB amendment application along with AREVA's environmental Management Plans will ensure protection of the environment.

Applications to authorizing agencies including a Project Proposal for mine development were submitted in November 2008. The mine development applications and proposal received a positive conformity determination against the Keewatin Land Use Plan in January 2009 and the NIRB made a screening recommendation for a public review of the Kiggavik Project to the Minister of Indian and Northern Development in March 2009. On March 2, 2010 AREVA received confirmation from NIRB that the Minister's decision indicated that the Kiggavik Project is subject to public review in accordance with Part 5 of Article 12 of the Nunavut Land Claims Agreement (NLCA). AREVA is applying for this amendment under Articles 12.10.2 and 13.5.5 of the NLCA that allow for continued approvals and licences for exploration activities when a project has been referred to a review.
