Please be advised that the proposed amendment to NWB licence 2BE-KIG0812 (as referenced in the email below) is considered by the Nunavut Impact Review Board (NIRB) to be a component of AREVA's "Kiggavik" uranium mine project proposal (NIRB File No. 09MN003). As you may be aware, the NIRB is currently awaiting the Minister of Indian and Northern Affairs Canada's (INAC) decision regarding the Board's recommendation that this project proposal undergo a review under Part 5 or Part 6 of the Nunavut Land Claims Agreement (NLCA).

At present, the Board is not able to provide a decision under Section 12.10.1 or Section 12.10.2 of the NLCA for this proposed activity without having a referral from the Minister of INAC for this file.
