Re: <u>Information Requests received from Parties regarding AREVA Resources Canada</u> Inc.'s *Draft* Environmental Impact Statement for the Kiggavik project

## Dear Parties:

On May 4, 2012 the Nunavut Impact Review Board (NIRB or Board) initiated the public technical review period for the *Draft* Environmental Impact Statement (DEIS) submitted by AREVA Resources Canada Inc. (AREVA or Proponent) for the Kiggavik project (NIRB File No. 09MN003). The NIRB invited interested parties to submit Information Requests (IR) to the Board on or before June 4, 2012 in order to facilitate their technical review of the DEIS. The deadline for IRs was extended to June 29, 2012 at the request of parties. The Board has completed its review of all IRs received and forwarded all appropriate requests that were directed to the Proponent under separate cover to AREVA earlier today.
