Thank you for the water licence inspection report. Curtis forwarded this on, and I am working on the various items identified. As requested I will provide further detail within the annual report.

We are gradually winding down and expect to be out of camp by Thursday or Friday this week. We have had great weather this past week and have almost finished servicing the third drilling rig at our laydown area. All equipment has been cleaned and put into seacans on site. The timbers, shack, and hose line remained in field as they do not have hazardous materials associated with them. One is located near our fuel cache and the two other shacks are near our Andrew Lake core storage area. If all goes well and we have no more fog days occur, we should be completely off site Thursday night/Friday morning. I can provide an exact date of demobilization later this week when I'm in Baker Lake.
