Hello [Phyllis](#),

I have been informed by our Project Manager and Geologist that the next hole that they are hoping to start may encounter artesian flow. Even if everything goes well with the seasonal maintenance to the drill, the hole would not be ready to start until Monday June 13<sup>th</sup>. Unfortunately we have not received the amendment approval yet and Monday is fast approaching. This hole is being drilled outside of the mineralization zone as part of the Project Environmental Impact Assessment for the purpose of conducting packer testing, installing a vibrating piezometer and collecting groundwater samples.

This drill hole is located at 14W 0565093 7146470 and is not near any lake or stream (at least 100 m away). During testing the packer acts as a temporary plug and does not allow water to flow from the drill hole. After the packer test is complete some water may have to be purged in order to collect a water sample fully representative of the groundwater system. Upon completion of the packer test and sampling, the drill hole will be permanently capped and sealed according to the licence condition.

I will give you a call tomorrow to discuss the status of our amendment request and answer any questions you may have regarding this hole.
