Good morning Michael,

John Robbins has asked that I answer the questions you have regarding the Kiggavik Project NWB water use licence. There is no change in water use in the requested renewal compared to the current licence.

- GPS coordinates for the sites of water taking: The exact locations are unknown at this time. When the project returns to the active phase the NWB will be notified as to which areas drilling will take place prior to the field season. Water proximal to the drill sties will be used as a water source. Figure 1.0-3 in the applications identifies viable water sources. Coordinates for water sources used will be reported in the Annual report.
- Information regarding the source of the water (i.e. is it groundwater? From lakes?): The water sources are lakes.
- Any information available on the fish and fish habitat of the waterbodies/watercourses where the water will be taken from: No specific information. AREVA ensures the intake complies with DFO guidelines for screens and placement to prevent damage to fish and fish habitat.
- Total volume and/or instantaneous flow measurements for the waterbodies/watercourses from which the water will be taken: The maximum daily rate is 81.76m³ per water source.

Please be advised that under the Agreement Between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in Right of Canada (Nunavut Agreement) Article 11, Section 11.5.9 and s. 76 (1) of Nunavut Planning and Project Assessment Act (NuPPAA), the proponent of a project governed by NuPPAA is also required to submit a project proposal document (which may include the water licence application) directly to the Nunavut Planning Commission (NPC or Commission) for the NPC's determination regarding the applicable land use planning requirements and/or directions regarding whether the project is subject to screening by the Nunavut Impact Review Board. In particular, please note that as established under Articles 11, 12 and 13 of the Nunavut Agreement, NuPPAA and Part 3 of the Nunavut Waters and Nunavut Surface Rights Tribunal Act, until the project has completed the applicable land use planning and assessment process required by the NPC and the NIRB, the NWB cannot issue a water licence. The NWB confirms receipt of NPC conformity under NuPPAA on December 14, 2017 and NIRB determination through NPC under NuPPAA on December 14, 2017. This application is now ready for review and comments. Deadline for submissions is **January 22, 2018**.
