Good afternoon Robert,

I apologize, I was out inspecting field projects for Northern SK projects last week and just getting to this. I want to get your thoughts on the outstanding two CIRNAC comments. I don't want to keep going back and forth with CIRNAC, but also can't make many adjustments to my initial comments at this time.

Ultimately, I won't have a change to response for #5 – SDS sheets. It is nearly impossible to have every possible SDS sheet attached to the Spill Contingency Plan, it would need constant revision and resubmission. Has there been a change to requirements, this was not required of Orano in the past and I don't see where the legislation has changed. The SDS for materials on site will be available on site, either in hard copy or electronically and updated as necessary.

For CIRNAC's comment #6 regarding the incinerator; I am unsure of how to respond to CIRNAC. I take their comment under advisement and propose that when the project returns an active phase we will have the discussion with NWB about the incinerator needs. I really can't commit to what that incinerator will be until that time.

What is the NWB requirement on these two items? I haven't noted a legislative change, but Orano does strive to adhere to or exceed best practices.
