AREVA plans to mobilize to Baker Lake to begin the 2016 Kiggavik field season on July 4, 2016. In addition to the detail provided with the annual report, I would like to provide a more definitive summary of the upcoming exploration activities. Two AREVA personnel and two to three local hires will travel daily from Baker Lake to the site of the Kiggavik camp to perform maintenance, inspect the site and prepare the camp for a care and maintenance phase. The camp will not be opened, workers will carry the necessary food, water and supplies to camp and haul refuse to Baker Lake each day. The work is expected to take no more than 14 days, weather permitting. No drilling, geophysics, prospecting, or geological mapping will occur in 2016.
