Good Evening,

I would like to inform you that an artesian was encountered in a drill hole in the AREVA Kiggavik lease at 1 PM today at a depth of 304m. We were alerted of its presence by the drilling staff at 3 PM and obtained a water sample at that time. The flow rate at time of sampling was 2L/min and the drillers state that this was the same rate of flow as when the artesian was first discovered two hours prior. The artesian is located at 562190E, 7143716N, and the drill hole containing it was discontinued at 3:15 PM and is currently being cemented and sealed.
