Craig - Attached is a guideline and information requirement sheet. The info sheet outlines information we would require to review the project for impacts to fish and fish habitat. The Guideline document is for BC, but the general concepts (preferences for design types) will be similar for Nunavut. Obviously, the Arctic environment needs to be taken into consideration in finalizing the plan.

Once you have an idea of the streams to be crossed, send us latitudes and longitudes and we can check to see if we have any fisheries information. The local Hunter's and Trappers Organization (Mayukalik Hunters' and Trappers' Association, P.O. Box 99, Kimmirut, NU, X0A 0N0, Telephone (867) 939-2355) may have some information as well. If you provide some pictures of the crossings, as soon as possible, we can determine whether a fisheries consultant will be necessary to investigate the streams for further information.

Other agencies you should consider contacting:

- You might want to touch base with the Nunavut Water Board as well, to determine whether a water license is necessary.
- If the road is on crown land, you should contact Indian and Northern Affairs (Spencer Dewar at 867-975-4283).
- If the road is Inuit-owned land, you should contact the Qikiqitani Inuit Association (867-979-5391).
- Environment Canada can be contacted at 867-975-4639.
