## Lupin/Ulu Update

Hi!

I had a good long chat with Karyn yesterday about what's up with the next stages of Lupin and Ulu.

First off, Karyn thinks she has requested we withdraw their application to renew 2BE-LEP1217. I've asked her to resend us something on letterhead so we can officially close off that renewal and then talk about what it would take to close that Licence.

For 2AM-LUP1520's amendment/renewal/closure plan... They hope that NPC will be done with it soon and that we can get moving on it ASAP. They want to collapse the crown pillar this summer (July) and that's one of 2 new things in this plan from previous plans. The other new thing is an optional additional land fill cell if they need the space. They note that this 'extra' landfill had been in earlier plans, but then removed again so it shouldn't cause any issues.

Lupin's team believe that they have collaborated well with CIRNAC and that there should be no push back or confusion with this application.

For 2BM-ULU1520 amendment... They hope that NPC will be done it soon, but acknowledge that the ULU team was concentrating on the Lupin security issue rather than moving the NPC ball forward for ULU. They also want this one by July, but given that it's a Type B and fairly simple, I don't see any issues there.
