Failure to address the deficiencies before the NIRB resumes the screening process may result in a suspension of the Board's assessment activities pursuant to Section 144(2) of the NuPPAA until the information is provided.

If North Arrow determines that the time required to supply the required information is significantly greater than 2 weeks, the Board requests written notification and an anticipated date for submission be provided as soon as possible.

1. Topic/Issue: NIRB Part 1 Summary Application Form in English and Inuktitut

Reference: NIRB Guide 3: Guide to Filing of Project Proposals and Screening Process

Rationale: The NIRB requires a complete NIRB Part 1 form in order to determine the scope of the project activities being proposed and to ensure sufficient information has been provided to commence screening. A translated version of the NIRB Part 1 form is required in order to assist unilingual community organizations, members and the public to understand and provide comments on the proposal.

Request: Provide the completed NIRB Part 1 Summary Application Forms in English and Inuktitut pursuant to the NIRB requirements.

2. Topic/Issue: Non-technical Project Proposal Summary in English and Inuktitut

Reference: Section 4 of the NIRB Part 1 Summary Application Form

Rationale: Summaries in English and Inuktitut are required to assist parties and unilingual community members to understand the proposal in a non-technical format.

Request: Provide the Non-technical Project Proposal Summaries in Inuktitut pursuant to Section 4 of the NIRB Part 1 Summary Application.

3. Topic/Issue: NIRB Part 2 Project Specific Information Requirements Form (PSIR)

Reference: Section 3 of the NIRB Part 1 Summary Application Form: Project Proposal Description

Rationale: To properly scope and assess projects that are proposing more substantial undertakings, the NIRB requires proponents to provide information on the proposed activities and associated components, on the potential environmental and socio-economic impacts, and on the proposed mitigation and monitoring measures related to the proposal.

Request: Provide a completed NIRB Part 2 PSIR Form in addition to any operational and/or environmental management plans associated with the proposed project. Please pay particular attention to the following when completing the NIRB Part 2 Form:

- Information applicable to the proposed project in Sections 1 and 2;
- Project specific information applicable to the proposed project as requested in Section 3;
- A description of the existing environment, the identification of impacts and proposed mitigation measures and a cumulative effects assessment as requested in Sections 4 through 6; and
- Submission of relevant supporting documents relating to your project proposal as requested in Section 7.
