Re: Notice of Part 4 Screening for Uranium North Resources Corp.'s "Mallery Lake" Project Proposal

Dear Graham Gill:

On February 2, 2011 the Nunavut Impact Review Board (NIRB or Board) received Uranium North Resources Corp.'s "Mallery Lake" project proposal directly from the proponent. On February 11, 2011 the NIRB received a positive conformity determination (Keewatin Regional Land Use Plan) from the Nunavut Planning Commission (NPC) for this file, and on February 18, 2011 the NIRB received an application for a Land Use Permit from Indian and Northern Affairs Canada. The NIRB has assigned this project proposal file number **11EN006** - please reference this file number in related future correspondence.

The proposed project is located approximately 135 kilometres southwest of the community of Baker Lake in the Kivalliq Region. The objective of the proposed project is to conduct early stage exploration for gold and other base metals in the area near Mallery Lake. The program is proposed to take place between April and September 2011 and continue to 2016.

The proposed project activities would include:

- Prospecting, geological mapping, sampling, aerial and ground geophysical surveys;
- Exploration drilling (reverse circulation and diamond drilling);
- Helicopter-assisted drill program, including daily transportation of field crew to drill sites and demobilization;
- Temporary tent camp facilities for a maximum of twenty (20) people near Mallery Lake;
- Twin/single otter transport of supplies, fuel and personnel to camp site from Baker Lake;
- Fuel storage at camp site (25,830 litres diesel and 30,750 litres aviation fuel);
- Temporary storage of chemicals and hazardous materials on site;
- Water use for drilling purposes and camp activities;
- Disposal of sewage, greywater and waste generated from camp operations;

- Incineration of combustible waste; and
- Removal of non-combustible and hazardous waste to an approved disposal facility.

The NIRB would like parties to provide comments regarding:

- Whether the project proposal is likely to arouse significant public concern; and if so, why;
- Whether the project proposal is likely to cause significant adverse eco-systemic and socio-economic effects; and if so, why;
- Whether the project is of a type where the potential adverse effects are highly predictable and mitigable with known technology, (please provide any recommended mitigation measures); and
- Any matter of importance to the Party related to the project proposal.
