## **Technical Review Memorandum**

2BE-MAL---- - New Water License Application - Mallory Project -

Kivallig Region - Uranium North Resources Corp.

### Background

Re:

The Mallory Project is located on Mallory Lake 135 km southwest of Baker Lake. The site will consist of four accommodation tents, a kitchen tent, a core tent, a dry tent, a first aid tent, an office tent, a generator shack and an outhouse. The site will be accessed by float plane and/or helicopter during the working season and will able to accommodate 12-20 people during the working season.

#### **Recommendations/Comments**

After reviewing the new application for water use 2BE-MAL---- from Uranium North Resources Corp. INAC would like to state that the application is well done.

However, INAC does have a few comments that need to be addressed and clarified.

#### Application

INAC reminds the applicant to forward all outstanding land use determinations and approvals that are pending (i.e., Nunavut Planning Commission (NPC) determinations and Crown land Approvals) to the NWB.

INAC reminds the applicant that written approval from any and all approved/authorized waste handling facilities within Nunavut should be provided to the NWB prior to the depositing any waste at those facilities.

INAC recommends that the applicant, once a determination has been made as to where the camp will be constructed; forward the location (coordinates) of the camp to the NWB.





INAC also recommends that the applicant forward, to the NWB when determined, all locations of water sources to be used with drilling activities.

Comment [W.1]: Bon

INAC reminds the applicant that the burning of camp waste/garbage is only permitted in an approved incinerator and that open burning of any kind is not permitted without Board approval.

#### Spill Plan

INAC recommends when Uranium North Resources Corp. knows who will be their on-site representative, that the contact information for the representative be submitted to the NWB and be included in an updated Spill Plan.

#### **Abandonment and Restoration Plan**

INAC reminds the applicant that open burning of any kind is not permitted without Board approval.

INAC recommends the applicant, if they wish, can apply for an open burn permit from the NWB at the appropriate time.

INAC recommends that the applicant provide, to the NWB, the above referenced outstanding information pertaining to the application.
