I am currently engaged in the planning and development of the 2014 field inspection schedule. While it is too early to predict the exact date, I hope to be in the Kivalliq Region and conducting inspections starting on the July 3, 2014 with your inspections scheduled for the **July 18, 2014**.

A request for closure of your Land Use Permit N2011C0006 has been received by the Aboriginal Affairs and Northern Development Canada (AANDC) Lands Administration Division. In order to close this permit, a final inspection will be conducted by an inspector duly appointed under the *Territorial Lands Act*. Furthermore, an inspection of Water License 2BE-MAL1116 will be conducted at the same time.

To assist me in preparing for the close of your Land Use Permit and Water Use Inspection, I request the following information:

- Names and positions of staff associated with the project
- A summary of the work that occurred during the life of the project,
- Confirmation of exact coordinates (degrees/min/sec, NAD 83) of activities (i.e.: fuel caches, camp, and drill locations).
- Information pertinent for a site visit (i.e.: recent activities, current plans, site hazards or restrictions, site safety protocols, etc.).
- Any other Land use permit (LUP) numbers associated with this site
- Outstanding documents or documents recently submitted to the Nunavut Water Board and/or AANDC Land Administration Division (i.e.: within the last 60 days)
- A notice sent to the Nunavut Water Board that clarifies the relationship between Adamera Minerals Corporation and Uranium North.

I remind you that annual reports must be submitted as per Part B of your license before the date of inspection. Attached for your convenience is a standardized template for annual reporting and a guide to assist. Please submit these completed documents to the Manager of Licensing at the Nunavut Water Board, [licensing@nwb-oen.ca](mailto:licensing@nwb-oen.ca).

Please respond to this request within 15 days. Failure to undertake the actions required as described in this letter, and to the satisfaction of the Inspector, may result in enforcement action(s) being undertaken pursuant to the *Nunavut Waters and Nunavut Surface Rights Tribunal Act* and *Territorial Lands Act*.

I am looking forward to our visit and hope we have the opportunity to work cooperatively together this coming year.
