Introduction

5050 Nunavut Ltd., a wholly owned subsidiary of Adriana Resources Inc. holds land use permit (License No. KTL306C016) on Inuit Owned Land Parcels (CO-52, CO-53, CO-60, CO 61 & CO-62) and NTS Map Sheet No. 86J, 86O & 86N for staking, prospecting, ground and air geophysical surveying, drilling, bulk fuel storage and maintaining a camp at McGregor Lake located approximately 80 km south of Kugluktuk in Nunavut. The permit is required to help advance the company's mineral exploration for nickel, copper, platinum, palladium and uranium in this area. The project consists of 91 claims comprising 230,001 acres in three areas i.e., All Night Lake, McGregor Lake, and UNAD Joint Venture.

Summary of Activities

The 2006 work included field and airborne geophysical surveys (SQUID and GEOTEM) field prospecting, surface sampling, and geological mapping. No drilling or other activities disturbing the ground surface were conducted. No wildlife encounters occurred during the exploration work.

The following reports providing details of the work carried out on the project are enclosed with this letter:

1. Report on the 2006 exploration program (geophysical surveys, prospecting and sampling) on Inuit Owned Lands (CO62-04-01 & CO62-0402), Nunavut.

2. Report on the 2004-2006 exploration program (geophysical surveys, prospecting and sampling) on All Night Lake Claims, Nunavut.

2007 Work Plan

Based on the results of 2006 exploration work, the project area continues to show promise for further exploration. The fieldwork program for 2007 will include: detailed uranium, nickel, copper and PGE prospecting and sampling; geochemical sampling; field geophysical surveys (EM and Gravity); and drill testing of the selected targets.

Camp

During 2006, Adriana Resources Inc. did not establish its own camp at McGregor Lake. Field personnel stayed in the Mouse Lake camp which was permitted and operated by UNOR Inc. and Adriana shared the cost of camp and logistics.

For 2007 exploration, Adriana Resources Inc. will establish its own camp by upgrading the existing INCO camp at McGregor Lake. As this camp has been used by various exploration companies, there is an issue of historical cleanup liability. An environmental assessment of this camp was performed in May 2005 by environmental consulting company (Golder Associates) contracted by Public Works and Government Services Canada (PWGSC). The report indicated presence of 760 fuel drums out of which 54 drums were full of hydrocarbon fuel, approximately 1,000 m³ of hydrocarbon impacted sol, and 575 m³ of metals impacted soil.

A copy of the above mentioned environmental assessment report is enclosed with this package.

On February 01, 2007 a meeting was held between representatives of Kitikmeot Inuit Association (KIA) and Adriana Resources Inc., to discuss Adriana's exploration project in the area and issues related to McGregor Lake camp cleanup. Adriana Resources Inc. reiterated that the company wishes to assist KIA in the cleanup of McGregor Lake camp and other historical exploration waste in the surrounding area; however it will not assume retroactive liability of the existing camp. A community consultation meeting was tentatively scheduled for June 2007.

Hiring and Training of Local Inuits

Adriana Resources Inc. is committed to hire and provide training to qualified Inuit. During the 2006 exploration program Adriana's field personnel stayed in the Mouse Lake camp which was operated by UNOR Inc. Local people were hired and trained by UNOR Inc. and Adriana Resources Inc. for camp and fieldwork activities. The names of local Inuits hired by UNOR Inc. to support Adriana's camp and field activities included:

Inuits Firms Contracted

Part of the project logistics such as travel, accommodation, fuel, groceries, tools and other camp requirements were procured from Kugluktuk, providing both direct and indirect benefits to the local community.

Helicopter Touch-downs

Two helicopters (AStar BA and Bell 206) were chartered from Canadian Helicopters by UNOR Inc. Adriana also used these helicopters for carrying out its field activities during the period from August 6, 2006 to September 15, 2006. Except for 5 weather days, 2 to 6 field personnel were dropped in the field everyday in the morning and picked back in the evening.
