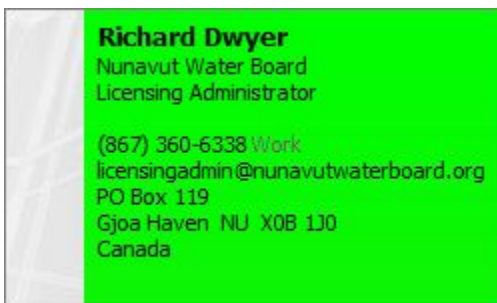
- Cover letter confirming that there will be no changes to the project
- English & Inuktitut summary of project and there are no project changes
- Water licence renewal application
- \$30.00 renewal application fee
- Nunavut Planning Commission (NPC) Conformity Review or Letter/E-mail from NPC conformity review isn't required for this project
- \$30.00 Water Use Fees for 2008, 2009 and 2010
- Spill Plan Addendum as per H2 of water licence
- Abandonment & Restoration Plan as per I2 of water licence
- 2008, 2009, 2010 annual reports as per B2 of water licence

If you aren't renewing your water licence we'll require by April 15, 2010 the following:

- \$30.00 Water Use Fees for 2008, 2009 and 2010
- Spill Plan Addendum as per H2 of water licence
- Abandonment & Restoration Plan as per I2 of water licence
- 2008, 2009, 2010 annual reports as per B2 of water licence

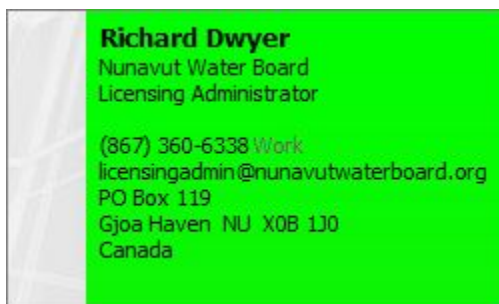
