Good afternoon;

The Nunavut Water Board (“NWB”) acknowledges receipt on May 11, 2010 of your new water license application for the McGregor Lake Project, file number 2BE-MCG0810

We undertook a preliminary administrative review of your application and conclude that, in accordance with approved legislation under the *Agreement Between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in Right of Canada* (“NLCA”), it does not contain sufficient information for the NWB to commence processing the file at this time. Specifically, we are asking you to provide the following:

- A copy of the spill report, which documented the diesel spill that occurred on July 31, 2009 and was reported almost a week later-This spill was mentioned in 2BE-MCG0810, 2009 annual report; and
- An up- to-date Uranium Management Plan-The plan on file was submitted May 7, 2007, under Adriana Resources Inc.
- NIRB Screening Decision (or confirmation in writing that a NIRB screening is not required)
- NPC Conformity (or confirmation in writing that an NPC Conformity is not required)

We will resume the processing of your application once we receive the requested information. The application and English Summary are attached for the reference of NPC and NIRB.
