Hi Gord,

I recommend you clean up the spill (and report it) in accordance with your (approved) spill contingency plan. It is your (company) responsibility to ensure all contaminated soil is recovered and removed from site: a landfarm requires specific approval from the NWB and requires consistent monitoring and handling. It is also your responsibility to ensure that this does not impact the water --and confirmatory sampling of the soil and water (ie. receiving environment) may be necessary.

I would suggest you contact Rob Eno (reno@gov.nu.ca) for information on contractors that can assist with proper disposal of the contaminated material (soil/substrate, wastewater, fuel, etc). You should already have a Waste Generator's number issued by the GN (www.gov.nu.ca/env/waste.pdf). Confirmation and receipt of movement of waste and final disposal at an approval facility are to be provided to myself. I would like a final clean up report confirming quantity of material removed ,showing where it went, copies of any manifests to be provided to me. I anticipate receiving a copy of this report by Aug 30th.

Melissa,

Steve is finishing putting my dormant McGregor Lake camp to bed. Stanley Anablak is on holidays, so I will see if Geoff can check it tomorrow, before Steve leaves.

This morning, Steve called me with two items of interest:

1. In the last 72 hours, He has seen 10 different bears passing within sight of camp. In my recollection (1985-86, 2000-2007) when the camp was active, we would only see two or three different bears over the course of a year. It may have to do with this year's caribou migration.
2. Sometime this year, there was a breach in one of the fuel berms; Steve has fixed the problem and covered the barrels.

He estimates the spill size as up to 45 gallons. It leaked into the soil. I've been told that for fuel in soil, something is mixed into the soil and it is periodically aerated. (Unfortunately, our on-site spill kit is designed for an active camp, where we can soak up a spill immediately. It's not designed to help once a spill has gotten into the soil.) Please let

me know whether I need to bring in something to mix with the soil, or if we simply start by digging the area up.

I suggest that you tell me how you would like this remediated. I will then get the stuff required and contact local labour to do the shoveling. Then you(or another inspector) and I fly in with the labourers, mark out the area to be remediated, and get the process started.
