Dear Ms. Gunson:

Please find attached Amendment No. 1 to Type "B" Water Licence No. **2BE-MDP1520**, issued to Apex Geoscience Ltd., by the Nunavut Water Board (NWB) (under Motion No. 2017-B1-025) pursuant to its authority under Article 13 of the *Agreement between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in Right of Canada (Nunavut Agreement)* and the *Nunavut Waters and Nunavut Surface Rights Tribunal Act*. The Terms and Conditions of the existing Licence, related to the use of Water and the deposit of Waste remain integral parts of this approval.

The Nunavut Planning Commission's (NPC) May 10, 2017 determination¹ confirmed that the scope of proposed activities in support of Amendment No. 1 is for an area that falls outside of the boundaries of the applicable regional land use plans in place and is exempt from the requirement for screening by the Nunavut Impact Review Board (NIRB) as the proposed project changes do not alter the general scope of the original project activities. Further NPC determined² that the project is exempt from section 235 of the *Nunavut Planning and Project Assessment Act* and that the exceptions noted in sections 12.4.3 (a) and (b) of the *Nunavut Agreement* do not apply.
