Re: <u>Clarification of Scope for NIRB Screening of the "Meliadine Gold Underground</u> Exploration" project proposal, NIRB File No. 10EA018

Dear Phyllis Beaulieu:

On January 24, 2011 the Nunavut Impact Review Board (NIRB or Board) received a request for clarification from the Nunavut Water Board (NWB) regarding NWB Licence 2BE-MEP0813 associated with the Meliadine Gold Project, more specifically with the property known as "Meliadine East."

The NIRB has previously screened exploration activities at the property known as "Meliadine East" through several project proposals submitted to the Board:

Most recently, on February 25, 2010 the Nunavut Impact Review Board received Comaplex Minerals Corp.'s [Comaplex; now Agnico Eagle Mines Limited (AEM)] "Meliadine Gold Underground Exploration" project proposal directly from Comaplex. On March 8, 2010 the NIRB received a positive conformity determination (Keewatin Regional Land Use Plan) from the Nunavut Planning Commission for this file and commenced screening the project proposal (NIRB File No.: 10EA018).

During this screening it was noted that the Project involved the expansion of the existing portal, ramp and existing infrastructure to conduct bulk sampling at deeper depths while completing the feasibility study for a potential Meliadine Gold Mine. It was also noted that some portions of the proposed bulk sample project had been previously screened by the NIRB (NIRB File Nos.: 03EN077, 05EN006, 05EN101, 07AN063, 08EN005 and 08EN043), including the following activities: winter road, wash car, waste water treatment plant, new wetlands area, bulk sampling tower and fuel transfer stations.

When describing the expansion of the exploration camp at Meliadine Lake, Comaplex noted in its February 2010 project proposal that "many of the additional sleeping and kitchen tents [would] be obtained from the demobilization of the Meliadine East camp, which Comaplex recently consolidated into the project." The NIRB understood this demobilization to mean that future exploration activities at the property formerly known as Meliadine East (NWB File No.: 2BE-MEP0913) would be based out of the camp infrastructure situated on the "Meliadine West" property (NWB File No.: 2BB-MEL0914) in support of one comprehensive Meliadine Gold Project.

As such, the NIRB included the exploration activities previously associated with the Meliadine East Project (NIRB File No.: 08EN043) within the scope of the Board's screening for the Meliadine Gold Project (NIRB File No.: 10EA018). The project proposal was screened by the Board in accordance with Part 4, Article 12 of the NLCA and on May 5, 2010 the NIRB issued the enclosed NLCA 12.4.4(a) screening decision to the Minister of Indian and Northern Affairs Canada indicating the proposed project could proceed subject to the NIRB's recommended project-specific terms and conditions.
