# A. BACKGROUND

On August 1, 2018, Agnico Eagle Mines Ltd. (AEM) submitted the above-mentioned application for the renewal of the Type B water licence 2BE-MEP1318 for the Meliadine East Project. This licence allows AEM to conduct exploration activities where they also have valid land use permits. Agnico Eagle maintains a land use licence with the Kivalliq Inuit Association and a land use permit with Indigenous and Northern Affairs Canada authorizing exploration activities in the area. The Meliadine East Project exploration areas are located mostly north and northwest of the Rankin Inlet community. The renewal covers the same exploration activities that were covered under this licence and includes no modifications to existing terms and conditions of the current water licence. Exploration activities in this area are sporadic and include camp operation, fuel storage, and mineral exploration (prospecting, geological mapping, geophysical surveys, diamond drilling, baseline data collection, and trenching). The 2017 Annual Report specifies that no activities were carried out under this licence in 2017.

# **B. RESULTS OF REVIEW**

The Water Resources Division of Crown-Indigenous Relations and Northern Affairs Canada's (CIRNAC) Nunavut Regional Office reviewed the documents associated with AEM's renewal application and would like to provide the following comments and recommendations for the Board's consideration.

# 1. Management plans not updated

# Reference:

Interim Reclamation and Closure Plan, Water Licenses 2BE-MEP1318 and 2BB-MEL0914, Agnico Eagle Mines Ltd., Meliadine East Gold Project, August 2013

#### Comment:

In response to new and changing activities on site, management plans should be updated to reflect those activities. CIRNAC recognizes that there was a lack of activity under this licence, since drilling last occurred in 2014, therefore management plans have not required updates. However, CIRNAC expects updated management plans with the return of activities on site.

An interim management plan, on the other hand, is designed to be active for only a provisional or temporary amount of time. The Interim Reclamation and Closure Plan, submitted in 2013, has not been updated in the past five years.

# Recommendation:

CIRNAC recommends that AEM updates the Reclamation and Closure Plan prior to renewal of this licence. Further, CIRNAC recommends that AEM updates the Spill Contingency Plan and the Abandonment and Restoration Plan as exploration and drilling activities evolve.
