Re: Extension Request for NIRB Screening of North Arrow Minerals Inc.'s "Mel Project" Proposal

Dear Ms. Carolyn Bennett:

On October 31, 2016 the Nunavut Impact Review Board (NIRB or Board) received North Arrow Mineral Inc.'s "Mel Project" proposal from the Nunavut Planning Commission for screening, pursuant to Part 3 of the *Nunavut Planning and Project Assessment Act* (NuPPAA). Pursuant to subsection 92(4) of the NuPPAA, the NIRB hereby requests that the responsible Minister(s) extend the period for the submission of the Board's written report for the screening of this project proposal, NIRB File No.: 16EN062.

On November 8, 2016 the NIRB distributed notice of the project proposal to potentially affected communities and interested parties, requesting comments be submitted for the Board's consideration by November 29, 2016. Due to concerns raised during the public comment period, on December 2, 2016 the NIRB provided the Proponent an opportunity to respond to the comments that had been received; a response from the Proponent is expected to be submitted by December 16, 2016. As a result of the additional time required to allow the Proponent to respond to the concerns and comments received, the Board requires additional time to complete its screening of this project proposal.
