Hello Assol,

Due to the shallow depths of the proposed geotechnical holes and the proposed sonic drilling technique, minimal amounts of drilling waste are anticipated to be generated during the drilling program.

If drilling waste is deposited in sumps during the drilling program, Baffinland will ensure the locations of the waste depositions are provided to the NWB in the annual report.

Drilling waste deposited in sumps will adhere to the conditions included in Part F, Item 4 of the Type B Water Licence and in general will be located within the proximity of the proposed drill hole locations.
