Thanks Justin. I recently spoke with Christine about her field inspection plans for the summer insofar as they affected Maze Lake. I see that you have cc'ed her here, so the information below hopefully is helpful to both of you.

- I am the primary contact for this project.
- The camp is located at 62°15'48.00"N 93°37'39.64"W (467436E / 6903769N).
- We are in the process of contracting with Discovery Mining Services to complete remediation of the property (primarily removal of drums of fuel and wood platforms). We hope this work will be undertaken in early-July, so the timing of your visit may be very good.
- Land Use License No. KVL308C03.
- I am not aware of any outstanding documents.
- I have looked through my files, and I do not have a notice to the Water Board that describes the relationship between Terrane Metals Corp. and Thompson Creek Metals Company. Such a notice may exist and may predate when I came to the company. I can tell you that Thompson Creek acquired Terrane as part of the deal that was primarily intended to acquire the Mount Milligan Copper/Gold Project in BC. By acquiring Terrane, we also acquired an interest in Maze Lake and a couple of other properties.
