Also Can you please submit the 2010, 2011, 2012 Annual reports for water Licence 2BE-NAD0813 and any outstanding water use fees.

<u>As Per Part B item 1</u>

The water use fees of \$30, payable to the Receiver General for Canada, shall be sent to the Board annually in advance of any use in accordance with Section 9 of the Regulations.

As Per Part B item 2

The Licensee shall file an Annual Report on the appurtenant undertaking with the Board no later than March 31st of the year following the calendar year being reported, containing the following information:

- a. A summary report of water use and waste disposal activities;
- b. A list of unauthorized discharges and a summary of follow-up actions taken;
- c. An up-to-date copy of the Spill Contingency Plan, including contact information;
- d. A description of all progressive and or final reclamation work undertaken, including photographic records of site conditions before, during and after completion of operations;
- e. A summary of all information requested and results of the Monitoring Program; and

f. Any other details on water use or waste disposal requested by the Board by November 1 of the year being reported.

In the future if an application for Land Use reference another License please ensure the Licence is in good standings.

If I am incorrect about the nature of this Licence please let me know and I will make the correction once the documents are submitted to me.

I did send the annual reports to Phyllis and Nicholas and I've attached them for your reference. As you can see from the 2012 report, we carried out a reclamation program at the camp, removing approx. 1000 empty drums. During this process, Biogenie, the Contractor, used up our remaining drums of fuel and diesel, so that all that is remaining is what was attached to the tents for heating purposes.

I'm not sure what is outstanding as regards the water use fee, but as we have done no activity since 2010, is this applicable anyway.?
