**RE: NANUQ PROJECT – SUMMARY OF ACTIVITIES FOR CALENDAR YEAR 2017**

---

Peregrine Diamonds Ltd. (“Peregrine”) holds AANDC class “A” land use permit N2012C0028. This permit authorizes land use activities at Peregrine’s Nanuq Project located 280 kilometres north-northeast of Rankin Inlet on 250K NTS map 56G. The permit was issued May 28<sup>th</sup>, 2013 and expires on June 13<sup>th</sup>, 2018. Peregrine also holds water use permit 2BE-NAN1318 which expires on June 30, 2018.

**Field Work 2017**

No field work was undertaken in 2017.

**Fuel**

On October 11, 2017 Peregrine received a phone call from RMO Christine Wilson from Rankin Inlet. In the telephone call RMO Wilson informed Peregrine of two (2) fuel drums observed on the sand airstrip approximately 1.5 kilometers southeast of the Nanuq Camp. Peregrine’s flight contractor Ookpik Aviation had advised Peregrine that all the drums (full and empty) had been picked up at the completion of the partial demobilization program in 2016. Peregrine cannot confirm that it owns the drums but will investigate in 2018.

### **Other**

To date Peregrine and its joint venture partners have spent approximately \$11,000,000 exploring the Nanuq mineral claims. All exploration activities on the Nanuq Project were suspended by Peregrine as the draft Nunavut Land Use Plan has designated much of the project area as prohibited to mining and exploration. This uncertainty needs to be ***clearly resolved*** prior to the commencement of future activities. Until such time Peregrine will, in good faith, maintain its existing land and water use permits.
