Subject: Authorisation to Use Municipal Landfill

Greetings, Paul,

A colleague and I met with you in February 2008, to briefly update you on Peregrine Diamonds and our exploration activities in the north Kivalliq (Wager Bay area).

We discussed at the time that we are operating a small seasonal tent camp (between 7 and 20 people), and we also discussed your capacity issues with the current landfill and your progress toward a new municipal landfill.

My question today regards how we go about obtaining municipal permission to deposit routine camp waste into the municipal landfill.

The current water licence for our Nanuq Project, located approx. 250km north of Rankin Inlet, requires that we obtain documented authorisation from the Hamlet of Rankin Inlet in order to backhaul waste to the municipal landfill. For the field season now under way until autumn, we require permission to backhaul non-hazardous waste from our Nanuq Camp to the municipal landfill.

Is formal authorisation required for backhauling landfillable waste? If so, how does Peregrine obtain this? (When Peregrine met with you in 2008, you did not indicate that there was a formal mechanism for obtaining this authorisation).

Are there designated areas that accept different kinds of waste, so we can identify these to our expeditors, M&T?

Are there designated areas for deposit of items that may be recycled?

Only items that cannot be incinerated on site will be transported out as candidates for disposal to the municipal landfill. Types of items for disposal would be similar to those for households or construction sites and would include the following:

- miscellaneous plastics (packaging, containers);
- glass (containers);
- metal scrap (including some wire and nails);
- incinerator ash;
- wood scrap (untreated);

- punctured empty aerosol cans isolated into marked containers;
- small batteries isolated into marked containers;
- used absorbent pads (from drip pans), bagged;
- bits of Fiberglas insulation (occasional only);
- Styrofoam (typically isolated from other packaging) - please identify if you accept, and if there is a designated area.

Peregrine would not be generating much hazardous waste (mainly used fuels, lubricants and filters in small quantity), but we are interested in information on whom the municipality itself uses as its Registered Waste Receiver for its own operations, as we would wish to contact this service provider for our own needs.
