I have reviewed both files and advise as follows:

2BE-NBP0305 - No fees are payable by any Federal Gov't Organization

There is no record of receiving annual reports for 2003 or 2004. This is a requirement of B1 of the licence. If there was no activity on site for those years please indicate same in a letter to the NWB.

In accordance with an amendment issued on September 9, 2005 there was a requirement to submit an addendum to the approved Spill Plan. This has not been submitted and is still considered as outstanding on the file..

Also, in accordance with the amendment issued in 2005 there was a requirement to submit, for approval, an abandonment and restoration plan. This has not been received and is still considered as outstanding on the file (see copy attached of amendment)

Once the outstanding obligations have been met the NWB will consider an application for cancellation.

3BC-HPI1213 - no outstanding issues related to this file. A application form for cancellation is attached for you use. Please note that a final AANDC inspection is required to cancel/close the file.
