Sorry for the late response. As for the 2007 annual report for Water license 2BE-NTI0507, this was submitted in Dec. 2013 – I have included another copy of it for you. Also, please find attached a **REVISED** 2005 Annual Report which takes into account the eight days of domestic water use that had originally been omitted (along with locations where water use occurred). And I also included a copy of the Final Abandonment and Restoration Report which notes the three fly camp locations in 2005 where water use occurred – no "before and after" photos were taken of the site unfortunately, but given the nature of the work and the short time period over which it was done there wasn't much to clean up.

Good Day Mike,

I have reviewed the file. We received the application for cancellation on September 5, 2013 and the file is incomplete administratively. An email was sent out on September 30, 2013 for the required information, but nothing was sent in.

In order for the file to go out for the 30 day review and comment period and move forward we need the following information:

- 2007 Annual Report;
- Revised 2005 Annual Report that accounts for the eight (8) days of domestic water use that was omitted from the submitted report under Licence No. 2BE-NTI0305;
- As specified in the AANDC Planned Inspection Report (June 6, 2013), provide the exact coordinates (Lat/Long [hddd^omm'ss.s"], in NAD 83) for the following:
 - All camp locations that were used at any time during the project (whether by your company or previous licensees under the same project);
 - Air strip/landing locations;
 - All drilling locations for the project (whether by your company or previous licensees under the same project); and
 - All fuel caches that existed in the course of the project, including an inventory of all petroleum products and chemical products that were stored on site.
- A copy of the Final Plan or dosure report, with photographs, documenting the steps taken to implement the Abandonment and Restoration Plan.

Once our office received the required information is received and completed it will go out for our normal 30 day review and comment period.
