Hi Cory,

Sorry for the late response. As for the 2007 annual report for Water license 2BE-NTI0507, this was submitted in Dec. 2013 – I have included another copy of it for you. Also, please find attached a **REVISED** 2005 Annual Report which takes into account the eight days of domestic water use that had originally been omitted (along with locations where water use occurred). And I also included a copy of the Final Abandonment and Restoration Report which notes the three fly camp locations in 2005 where water use occurred – no “before and after” photos were taken of the site unfortunately, but given the nature of the work and the short time period over which it was done there wasn’t much to clean up.
