This is a cancellation for a Type B Licence involving the Prince of Whales, Chartrand Lake, and Devon Island projects, with DeBeers Canada Inc. as the Licensee.

The last communication I have, sent by Courtney Cox (INAC) on August 14, 2014 to Robin Ikkutislum (NWB), states under the **Recommendation** that:

"The Licensee should inform the Water Resources Office the contents of the crates or boxes identified near the Devon Island Houghton Crater Site and ensure that they are properly disposed. The licence should be cancelled when a Water Resource Officer provides written confirmation that no compliance issues remain outstanding with the project."
