To my knowledge, we do not currently issue Certificates of Completion or Closure. The NWB will require me to sign off as being confident that all activities have been reclaimed in accordance to the A&R plan. As you know, I am still uncertain that we have a fulsome picture of the activities conducted under this licence. The information requested as a result of the inspection will help me to determine the next steps with respect to this licence.

Hi Chris,

I can totally appreciate the confusion. This file is not as straightforward as one would like! Nor is the process. Thank you for forwarding this information; it's great that you kept it. Now that you've brought it to my attention, I can see in our internal database the e-mail and attachment that you sent to Andrew on August 31 2012. As you can imagine, a pdf entitled "2078_001" did not jump out at me as having particular significance. Andrew is not in the habit of changing the subject on e-mails or attachments when he files them, so you can imagine how fun it is to try and find things after the fact! That said, the Annual Reports still have to be filed with the Board for all years. I just checked the public registry, and Phyllis never posted the 2008 reports that you submitted in the March 13 2009 e-mail (I only checked PCD and KIK not the other two). That happens sometimes; she gets pretty bombarded at Annual Report time... The onus is on the Licensee as per Part B item 7 to ensure that documents are received and acknowledged. Judging from your e-mail it doesn't appear that she was copied on the August 31 e-mail either. As I said, it's a good thing you kept the messages!

It will be up to the Board to determine whether they accept that letter in lieu of actual Annual Reports for those years, and whether they will waive the requirement for the SCP and AR plans since the project is concluded. Please re-send all of the documentation to Phyllis so that it can be properly posted to the Public Registry. Unfortunately, we at AANDC can only see what gets posted, unless we're copied on the original e-mails.

Note: the NWB has updated their e-mail system; Phyllis Beaulieu is copied above at her new address.

Hello Ms. Paul:

Thank you for the information.

I am working towards finalizing this issue however I do have one point of confusion; within your letter you state that Andrew Keim requested information but that it was not provided, i.e. Final Reports for 2008 – 2012 as well as addendums filed for the Spill Contingency Plan or the Abandonment and Restoration Plan. I have attached an email sent to Mr. Keim on August 31, 2012 with the requested information. As I did not receive a response from him I assumed all was well and final inspection and closure of the licence would be forthcoming.

I also have attached an email with the 2008 annual report as sent to Phyllis Beaulieu.

I am also working with members of the team who have assured me that no item was left at any of the locations indicated in your document. Since no work has been done in any of these locations since 2007 I must assume the crates or boxes observed belong to the group using the airstrip at the time of your inspection.

I will continue to gather information required however clarification on the submission of the Annual Reports for 2008 - 2012 would be helpful.
