Hi Zoe,

If you could submit to me the Final Plan, I would appreciate that. If coordinates are not explicit in the Plan, then please also provide the Form with all past camps and fuel caches identified. Graham never did send me the detailed cleanup reports, as far as my records show, following the 2012 inspection. But I'm happy to know that everything has been pulled out.

As no annual reports are on the public registry for 2012 or 2013, those will have to be filed. I've attached the standard reporting form, which includes a section on 'Progressive Reclamation Work Undertaken'. Please ensure that the reclamation work is documented (and you can submit a copy of the Final Plan also), waste manifests are attached, and report any water use/waste deposit for those years.

The cancellation application may not be required by the Board; a letter may suffice as the licence has expired. But the Board does need evidence that the A+R requirements have been met, and then will request that I conduct a final inspection.

With respect to the drums in Kugaaruk; the inspector for Kugaaruk will address the issue with the hamlet. He is satisfied with the documentation that the hamlet accepted the fuel from DN/Adamera.
