Our process had changed over the past years that the NWB requires NPC Conformity and NIRB Screening for all projects. If there is no requirements for an NPC Conformity our office requires written confirmation on to that office. When any project changes from its previous submission it is necessary for NIRB to resource of previous screening decision. All Applications

require a brief project summary in English and Inuktitut this summary should indicate what your Amendment is for. In your case identifying closure of one camp and opening another would be necessary. These summaries assist our Inuit speaking board members to understand what the project entails.

Firstly you have sent me an Advanced exploration questionnaire which does not apply to this project as it is only in the exploration stage, i.e. not bulk sampling or underground drilling.

Secondly, I am at a loss as to why Diamonds North needs to have this project screened again by NIRB or why it needs to go to NPC for a conformity check when this has already taken place under our current Licence which allows for 2 camps. The amendment request is only for a relocation of the secondary camp from the Siku site to the new Tunerq site with no change in water consumption/waste disposal for the Licence itself.

I can see why the A and R and Fuel Spill Contingency plans need updating in terms of location/contact information and will provide shortly.

What kind of executive summary are you looking for? Is it Siku shutdown or the new proposed camp or both and why is this necessary when we are allowed two separate camps?
