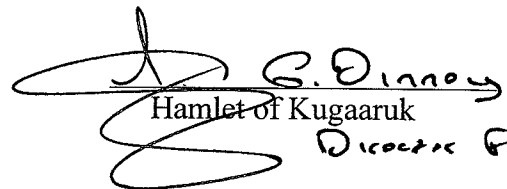

To Whom It May Concern:

Diamonds North is planning a grassroots style exploration program on our Amaruk property In 2009. The main camp is located approximately 45 kilometres southwest of Kugaaruk. It is anticipated that the program will run for about 6 months and involve a crew of 25-35 men. Our current plan will be to incinerate combustible garbage on-site to minimize the amount of garbage in the camp area and to reduce the amount of wildlife-man conflict. Upon incineration we will be placing the ashes and un-burnt cans etc. into double garbage bags/empty 45 gallon drums for transport. We expect 10-12 bags of ash per week. There may also be a few small items of non-combustible solid waste that will also need to be removed from site but it is not expected that these would contain any hazardous waste. To that end we are requesting permission to use the landfill/disposal site in Kugarruk to dispose of our garbage.
