## General Background Information on the Project (\*optional):

This project was originally operated by BHP Billiton Diamonds Inc. until they decided not to continue with their option agreement. In May of 2006 a request was made that the original water license (NWB2PEL0507) be assigned to Diamonds North as we are now operator of the project. The licence was assigned to Diamonds North on June 20, 2006. In 2008 a new water licence was issued to Diamonds north to continue with their exploration efforts at Amaruk. In 2013, Diamonds North Resources amalgamated with Uranium North Resources to form Adamera Minerals Corp.

Additional Details:

General: Due to the economic downturn, the remote location, and high cost of work in

the north, Diamonds North decided after the 2011 field season to cease work on the Amaruk Project. In 2012, no exploration work was conducted and abandonment and restoration of the area commenced.

All drill sites from previous years were inspected upon completion of the hole, all drill sumps were backfilled and leveled, drill collars were cut off to ground level, and drill pads returned as near as possible to their original state. All garbage and fuel drums were collected and flown to camp for incineration or removal to an approved disposal location.

All buildings, contents, and equipment including generators, pumps, hoses, incinerator, drill and ancillary equipment were dismantled and removed from the property. No fuel remains at the camp or at fuel cache locations on the property. Empty drums were backhauled to Kugaaruk/Yellowknife/Churchill during the course of the program and the remaining drums have been removed from Apron B at the Kugaaruk Airport. The grey water sump was in-filled and the latrine sump was buried at the time of the last demobilization of the camp. Abandonment and restoration of the camp, drill sites and fuel caches has been completed.
