## Phyllis,

I did have a look at the application.

If I understand they are not planning to have a camp (so no need for a camp questionnaire).

However, I identified some missing information with the Spill Plan entitled "Fuel Management Plan Peter Lake Project".

The Spill Plan should be in the format set out by the Consolidation of Spill Contingency Planning and Reporting Regulations R-068-93 addressing the following issues:

- Identification of the person in charge including their name, title and contact information;
- Identification of a 24 hour contact person including their name, title and 24 hour phone number;
- Inventory of Hazardous material that is estimated to be stored/used during the drilling activities;
- Explanation of spill procedures in the event of a spill in land, water and ice;
- Discussion on how the spill plan is activated;
- Identification of the plan's effective period;
- Description of the contents of the spill kits;
- Inclusion of the 24 hour Spill Report Line and INAC Inspector into spill reporting procedures; and
- Inclusion of DIAND, EC, GN-DOE, DFO, KIAs in the emergency contact information.
