On June 9, 2017 the Nunavut Water Board (NWB) received a final water inspection report from Indigenous and Northern Affairs Canada (INAC) covering the above noted file. The report indicates there are no outstanding reclamation issues associated with the project. Further, there are no outstanding NWB administrative matters that require attention.

In accordance with section 43.(i)(c) of the *Nunavut Waters and Nunavut Surface Rights Tribunal Act* (NWNSTRA), the Board may cancel a licence in certain specific cases.

The NWB hereby notifies all parties that the aforementioned licence is now cancelled and that the corresponding NWB file is now considered closed. Any future relevant activities on this site will require a new Water Licence or Approval Without a Licence.
