A. Project Description

Ashton Mining (Northwest Territories) Ltd. submitted a request for closure to the Nunavut Water Board (NWB) on August 31, 2012 and held an existing water license 2BE-PIX0510 (expiring August 1, 2010). The license was authorized to use up to 5 cubic meters of water/day (not to exceed) in association with a temporary fly camp to be constructed on Inuit Owned Land parcel BB-16 located 80km south of Bathurst Inlet. The camp was to occupy a footprint that would not exceed 130m².

Given the camp was never constructed during its 5 year license term; there are no reclamation activities to report.

B. Results of Review
