Good Morning David,

Keeping in mind that any water use above 300 cubic metres per day triggers a Type A process. Can you confirm that the quantity of water used for drilling will be 295 m³/day while the amount of water used for domestic camp use will be 5 m³/day. Based on the requested amount, the proposed total quantity of water under the requested amendment licence is to increase from 299 to 300 cubic metres per day.
