Thank you for the info below, much appreciated.

In completing the technical review of the application as well as the 2BE-QAM file, it was noted that the 2006 Annual Report, as required by Part B, Item 2 as well as Part I, has not been received by the NWB. As this report is required for compliance reasons and renewals/amendments are generally not issued under conditions of non-compliance, the NWB requests that a submission to fulfill this condition of the Licence be provided prior to the issuance of the amendment.  > Good morning Garth,  
 >  
 > I am in the process of getting your application for amendment finalized  
 and  
 > to the Board members for approval and just wanted to confirm a few things.  
 >  
 > In your application, I couldn't find anywhere that it actually stated what  
 > was being requested in the amendment. What I needed to do was go through  
 > the details and compare with what the original applicaion was for and what  
 > was covered in the current Licence.  
 >  
 > What I have things narrowed down to in the application are:  
 >  
 > 1) addition of the drilling component as 2BE-QAM0608 does not allow for  
 > drilling; and  
 > 2) increase in the amount of water use to allow for the 55m3/day required  
 > in drilling; total would now be 60m3/day max.  
 >  
 > The application also does not include lats/longs for the project itself.  
 > Map2 gives a good location of the overall project, however the coord. are  
 > UTM and for no better reason than not having the ability (or knowledge) to  
 > convert, I don't have the lats/longs. Could you provide those. my rough  
 > guess is in the area of 64-65N and 97.5-99W.  
 >  
 > Other than the above, if there is anything else that needs consideration  
 > for the amendment, please let me know. I am hoping to get this to the  
 > Board members this afternoon, which should see the Licence issued  
 (assuming  
 > approval) by mid-next week. Please give the Phyllis or Richard a call  
 > (867-360-6338) to check on the progress next week.
