Enclosed is the Nunavut Impact Review Board (NIRB) Screening Decision Report to the Honourable Chuck Strahl, Minister of Indian and Northern Affairs Canada (INAC) and Jose Kusugak, President of Kivalliq Inuit Association (KivIA) for Cameco Corporation, Turqavik-Aberdeen Exploration Project Proposal in the Kivalliq Region.
