At this time we do not know where specifically we would like to drill, and we don't know how many holes we would like to drill either, which is why we only submitted a single location. You are correct, there will be many drill holes, and it will be some time before we know the exact locations – we can submit the drill locations once we have them, but this will not likely be until we are at the site and ready to drill.
