Good day Mike, as discussed previously it has been noted that several water use fees were collected since 2012 which should not have been paid due to the fact that no water use is currently authorized under the above licence. Consequently you now have a credit which will be applied to future payments, as agreed to by yourself...

In March of 2012 a water use fee was collected for \$73.00 but only owing was \$8.40. Subsequent payments of \$73.00 each were received for 2013 to 2015 for a total credit of \$356.00 . I will use \$30.00 of this credit for the administration fee for the current amendment before the Board, leaving a credit of \$326.60. I trust this is satisfactory to all parties.
