Thank you for your email;

A review by NPC of a proposal or a renewal/amendment to a project is generally triggered when an application or request is received from a land use authorising agency, I believe in this case the Nunavut Water Board (NWB). Upon receipt, the NPC will review and determine whether a conformity determination is required.

To date, the NPC has not received a proposal, or a renewal/amendment application as described above from the authorising agency.

Hi Brian,

My name is Mike MacMorran and I am writing in regards to a conformity review for a Nunavut land use permit for some drilling we would like to do near Repulse Bay, NU (Kivalliq Region). North Arrow Minerals Inc. is conducting work to complete a joint venture option agreement with Stornoway on the Qilalugaq Project. We have already prepared and submitted the NIRB application documents to GN-C&GS (as the property sits on Commissioner's Land), and we have also submitted an application for a new water license to the NWB (we appended the NIRB application to the water license application for continuity). We have mailed printed hardcopies to GN-C&GS, and we have sent digital copies via email. NIRB has said that we should submit the application to NPC first for a conformity review which we would like to do now – can you tell me if you have a preference, digital or printed? Digital will obviously be faster, but I'm happy to do both. If digital is ok with you I can start sending the documents today – it will unfortunately take multiple emails as some of the documents are large.

Once the joint venture agreement has been finalized, North Arrow expects to transfer all mining leases and associated land use permits into the company's name – we anticipate this will take place later this year. North Arrow will be the operator of the Project for the proposed drill program(s) this year and next.

Also, please let me know if there are any application fees required and I can phone you with a credit card number (C&GS required an application fee of \$50).
