Hi Karen,

Hope you're well! I'm hoping you can help me with this, I'm trying to remember what we decided to bump the total water use per day number up to for the 2BE-QIL1217 Amendment Application I submitted back in February. I remember Phyllis had called me with a few questions (one of which was how much water we wanted to be approved for per day) – we applied for 60-80 cubic metres per day in the application, but I think we increased it to 100 following our conversation. Phyllis is away from the office right now, so I was hoping that you could confirm this for me. Also, can you tell me what the annual cost for water use is (I know from discussions I've had with Phyllis that the NWB charges based on permitted/allowable daily use, not the actual daily use) – what is the \$/cubic metre?
